By submitting any material to Impact73.org/PPL, you automatically grant that you are the sole owner of said material, or warrant the owner of said material has granted Impact73.org/PPL the royalty-free, universe wide, perpetual, irrevocable, non-exclusive right and license to use, reproduce, modify, adapt, publish, display, translate, perform, edit, transmit, reformat, sublicense and distribute, such material and/or incorporate it in other works in any form, media or technology now known or hereafter developed, and you understand that Impact73.org shall have no obligation to copy, publish, display or otherwise exploit the materials, nor shall they be obligated to prevent, or have any liability for, any unauthorized copying, publishing, displaying or other exploitation of the materials.
